WHEREAS:

1. The Employer, after due process of the Supply Chain Management, awarded a tender under contract no. 8/2/2/15-2014 to the Contractor to render for the Supply, Delivery, Installation and Maintenance for the PBX telephone system (“**the Project**”) for the Employer;
2. The parties concluded an agreement which was set to endure for a period of three (3) year, with effect from 1 November 2014 to 30 October 2017, (hereinafter referred to as the main agreement);
3. The Parties later entered into Addendum 1 which extended the main agreement for a further period of three (3) years commencing on 1 November 2017 to 30 October 2020.

NOW THEREFORE THE PARTIES AGREE AS FOLLOWS:



2. For the period of the extension, the scope of the work and the project fee shall be increasing in accordance with the estimated yearly CPI % index.
3. The contents of this Addendum are the only amendments to the main agreement, the terms and conditions of which shall remain valid and binding on the Parties until the agreement terminates.
