### **SEDIBENG DISTRICT MUNICIPALITY: SPECIAL CONDITIONS OF CONTRACT IN TERMS OF SECTION 37(2) AS WELL AS THE CONSTRUCTION REGULATIONS CONTEMPLATED IN THE OCCUPATIONAL HEALTH AND SAFETY ACT, ACT 85 OF 1993 SHE 5.42**

It is an express condition of this contract that –

1. the contractor binds himself unconditionally and irrevocably, for the purposes of the provisions of the Occupational Health and Safety Act, 1993 (Act 85 of 1993), to act as employer in own right and therefore to accept full responsibility for the health/safety of his employees and other people in the execution of this contract;
2. the contractor shall strictly adhere to and ensure that his employees adhere to, the prescriptions as contained in the Occupational Health and Safety Act, 1993 (Act 85 of 1993) and Regulations (regulations promulgated in terms of the Machinery and Occupational Safety Act, Act 6 of 1983);
3. the contractor shall discuss and negotiate (see contact details in point D below) a suitable, sufficiently documented health and safety plan which inter alia include:- OHS Budget, Machinery involved, site establishment, methods of work, risk assessments, OHS Officer's appointment, H/Safety Rep appointments and various other obliged appointments, Fall Protection Plan preparer, Stacking Controller, First Aider, Fire Fighters, emergency numbers/evacuation plans (all backed by a Seta Approved valid certificate/s) and shall furthermore, notify the Council in writing of the name of his Safety Coordinator **prior** to the commencement of any construction work as contemplated in the Construction regulations in the OHS act, act 85 of 1993;
4. the contractor's Safety Coordinator referred to in point A below shall, immediately when needed, or as otherwise agreed, contact the Council's designated representative (see point D below) in connection with health/safety related matters, (see telephone number – 4 below);
5. the contractor shall, in terms of section 89(1)(a) of the Compensation for Occupational Injuries and Diseases Act, 1993 (Act 130 of 1993), be registered and that his contributions shall be paid up to date, for the full duration of this contract, and that the contractor shall accept full responsibility for his subcontractors, with respect to the registration fees and period payable in terms of the latter section;
6. the contractor shall notify the Council in writing of the appointment of any subcontractor and furthermore, that the contractor shall accept full responsibility for the health/safety of the employees of the subcontractor;
7. the contractor shall without delay notify the Council in writing of all dangerous or potentially dangerous situations which may arise from the execution of work by the contractor or subcontractor;

8. the Council may take any reasonable steps deemed necessary to ensure compliance with the provisions of the Occupational Health and Safety Act, 1993 (Act 85 of 1993);
9. the contractor shall take all possible precautionary measures to protect the safety of the general public;
10. the non-compliance with any of the above-mentioned paragraphs shall amount to breach of contract which will enable the Council of cancel the contract, subject to other applicable provisions;
11. the non-compliance with the above-mentioned provisions by the contractor shall not cause liability to the Council and the contractor shall indemnify the Council against any loss or injury/disease which any person may sustain and he shall also waive any right, of any nature, to institute a claim against the Council as a result of injuries/diseases or incidents arising from his activities in terms of this contract.
