CONDITIONS OF TENDER

1. The prospective bidder's attention is drawn to the following list of forms, attached to this document and other documents that **shall** be completed and submitted with his/her bid documents:

In terms of Section 112 (1)I of the Local Government Municipal Finance Management Act, (Act 56 of 2003), persons who were convicted of fraud or corruption or who willfully neglected, reneged on or failed to comply with a government tender during the past 5 years, or whose tax matters are not cleared by the South African Revenue Services may not participate in the tendering process and the Tenderer shall submit a sworn statement to this effect.

2. **The official tender form shall be completed in BLACK ink and any corrections to the official tender form must also be made in BLACK ink and signed by the bidder. Any tender documents received with correction fluid (Tippex) corrections shall be disqualified.**
3. Bids shall be sealed and endorsed (with bid number and bid description) and must be deposited at Sedibeng District Municipality's tender box (Ground Floor, outside the main building).
4. Sedibeng District Municipality's Supply Chain Management Policy shall apply.
5. Late, Telexed, faxed or emailed tenders will not be accepted.
6. The Council does not bind itself to accept the lowest or any tender and reserves the right to accept any tender in whole or in part.
7. Persons in the service of the state are not allowed to bid.
8. In the event that you are awarded a tender the strict compliance with terms have to observed and in so doing within a period (3 days) (*after an order is issued) a confirmation letter must be forwarded by you in terms of which you need to indicate whether or not you will be in a position to source the items per the tender and deliver same by the due date.

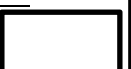

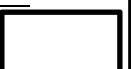

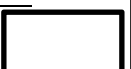

Background

Sedibeng District Municipality wishes to invite prospective bidders to submit their applications to become part of a framework agreement between the Sedibeng District Municipality and its appointed service provider for the purpose of service, mechanical diagnostic and repairs of garden machinery. The proposed agreement is aimed to be for one (1) year with an option to renew annually for two (2) more years based on the service provider's performance and budget availability.

Appointed service provider will assist the Sedibeng District Municipality's Cleaning Unit within the auspices of Facilities management directorate with the routine service, general mechanical diagnostic and repairs of the Municipality's Garden machinery as and when required.

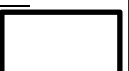
Scope of Work

This document seeks to provide a summary of related services regularly required by the municipality:

- Conduct routine service, mechanical diagnostic and repairs of garden machinery;
- Provide technical advice on the projected scheduled maintenance of garden machinery;
- Conduct basic machinery handling drill to operators for the purpose of proper usage and handling of machinery to enhance life span of the asset/s.

No general specification is provided, but the work will include all normal mechanical diagnostic, repairs, routine service and replacement of defective devices that is normally associated with mechanical and electrical repairs of garden machinery. The actual scope of each job will be determined by the maintenance requirements of the individual machinery and its service requirements; such will be on a need basis or routine/ scheduled service.

The garden machinery ranges from: Ride-on lawn mower tractor, Self-propelled Walk behind lawn mower, walk behind lawn mower, Bush cutters, Trimmers, Blowers, Hedge trimmers and Chain saw. All the listed machineries are petrol operated. Electric operated machines/ appliances such as vacuum cleaners and related cleaning appliances will be repaired on ad-hoc basis

The quotation will be evaluated by the Council Official concerned and if satisfied that the costs and timeframes are reasonable an official purchase order will be mailed and also be physical collected. No work may be carried out or will be paid for if no official purchase order has been issued beforehand.
